# 1. Review of Action Items

- The agenda topics will be covered by the committee leaders.
- Hilyard commented that the meeting time of 04:00 UTC shall be fine to the Pacific community. The main purpose is for the attendees to ask questions.

- The secretariat relayed the message from Sylvia Cadena on the mailing list
  - "I would kindly request those tasked with 5 minute presentations share an outline of what content are they going to cover to make sure that 1) we don't repeat each other; 2) we focus on existing procedures/forms to encourage people's participation in an organized/manageable way; 3) to have an agreement about what is the message to the community.
  - I see the webinar has 2 main purposes: 1) encourage participation (organize your travel early, consider to apply to the fellowship opportunities available -limited numbers-) and 2) support the development of an attractive program by submitting proposals that reflect your issues and concerns as well as to offer your expertise as Resource Persons. It is key that we agree about why are we doing the webinar, to keep focus"

#### 3. Resource Person Sign Up Form

- The secretariat has posted the resource person sign up form (http://igf.asia/2018rpform) on the main website and created the wiki page for the list (<u>http://igf.asia/wiki\_aprigf</u>)
- Joyce raised the questions about the purpose of the form whether it is only targeting the local stakeholders or Pacific. The secretariat and other MSG members responded that the form does not limit to local stakeholders but anyone planning to attend the conference to contribute. There is a consensus that the resource person lists shall be inclusive for wider Asia Pacific community while effort will be made via PICISOC to outreach to the Pacific community in specific.
- Joyce asked if remote speakers are welcome to sign up the form. Secretariat echoed that shall remind workshop organizers that they can include remote speakers e.g. people signing up the form and stating they have no funding yet at the moment.
- Joyce suggested to add the workshop themes reference in the form to guide the people's answer on the area of expertise.
- There is suggestion that "Resource Person" is not clear enough on what is expected of a person and therefore agreed to change to "Potential Speakers List" and specify that they may be invited by workshop organizers as a speaker.
