1. Review of Minutes and Action Items

- The workshop proposals submission deadline has been extended and closed now.
- The 2019 local host candidates have responded to the clarification questions.

2. 2018 Preparations

Local Host Updates

- **Venue:** Secretariat updated that the local host is awaiting hotel quotations to finalize the meeting venue. The potent venue change was due to the lack

of budget for renovation of the Convention Center to ensure the facilities work. It might result in less meeting rooms and some might be built with marquees.

- **Remote Participation:** Secretariat updated that due to the security issues of adobeconnect, ICANN has suspended its remote participation tool during ICANN 61 San Juan and hence advised APriGF to seek alternative back up. APNIC confirmed that they will be able to support the adobe connect rooms yet 2 parallel sessions only. Secretariat is also in talks with ISOC to explore zoom.
 - Hong mentioned in the chat that ZOOM is no longer working in China and encourage other alternatives being pursued.
- Cheryl raised concern on the late notification of the change without a resolution and fail to update the MSG promptly.

- The Program Committee will have an evaluation deadline until 23 April and finalize the result in early May.
- **Conflict of Interests:** The MSG agreed that Program Committee members shall recuse themselves from evaluation of the specific proposal if they are the workshop organizer or as proposed speakers for transparency and accountability.

Fellowship Committee Updates

- **Fellowship Application:** Sunny updated that 133 applications received on the system and the Committee agreed to accept 2 late applications who experienced technical difficulties and have contacted the secretariat prior to the deadline.

- **Statistics:**
 - Gender - 93 Male; 42 Females
 - Most applications come from Civil Society and Academia
- The Committee target to finalize the evaluation by next MSG meeting and put out a shortlisted candidates for MSG resolution.
- **Current Available Funding:** \$46,000USD (with \$3,500 from IGFSa pending confirmation)
- There is a question from whether the Fellowship process is separate with the program evaluation and it is confirmed that the proposals will be evaluated based on merits regardless if it is fellowship-dependent.
