Overview

Initially a hybrid event to be held in Kathmandu, Nepal, the 16th Asia Pacific Regional Internet Governance Forum (APrIGF) transitioned to a fully virtual format as of 16 September 2025, following a series of unfortunate events that took place in Nepal after the government's ban on social media platforms in early September 2025.

The APrIGF 2025 was held online via Zoom, organised and executed by APrIGF Multistakeholder Steering Group (MSG) and APrIGF Secretariat, with Day 0 taking place on 11 October 2025 and concluding on Day 3, 14 October 2025.

The overarching theme this year was "*The Future of Multistakeholder Digital Governance in Asia Pacific*", which highlighted 5 thematic tracks; Security & Trust, Resilience, Innovation & Emerging Technologies, Sustainability, and Access & Inclusion,

About APrIGF

Asia Pacific Regional Internet Governance Forum (APrIGF) serves as a platform for discussion, exchange and collaboration at a regional level, and also where possible to aggregate national IGF discussions, ultimately advancing Internet governance development in the Asia Pacific region.

In 2010, while the global IGF is already in its fifth and final year of its initial charter, and Regional IGFs have been established in many other regions, including Africa, Europe, Latin America and the Caribbean, to date, Asia has seen no parallel forum for discussing Internet governance issues at a regional level. For the first time, the APrIGF is therefore being convened with objectives to raise awareness and encourage participation from relevant stakeholders around the region on Internet governance issues, as well as to foster multi-lateral, multi-stakeholder discussion about issues pertinent to the Internet in Asia.

The multi-stakeholder approach is a core principle of the APrIGF with the emphasis on the diversity of participants and openness of the discussion. Valuing the youth as an important stakeholder and the future generations of the Internet, a Youth IGF also becomes an integral part of the APrIGF whereby they are held in parallel annually featuring a simulation of the multi-stakeholder discussion model among the young people on various Internet governance issues.

The APrIGF places significant emphasis on the diversity of participants and openness of discussions through its multi-stakeholder approach. The APrIGF is led by the Multistakeholder Steering Group (MSG), composed of members from diverse stakeholders across the regional Internet community, who are responsible for deciding on the overall direction, theme and program content for the annual forum.

About APrIGF 2025

Theme & Tracks

The multistakeholder model of Internet governance is under pressure globally, challenged by geopolitical fragmentation and corporate dominance, among other issues. In the Asia Pacific, these global shifts intersect with a complex regional landscape marked by vast socio-economic inequalities, uneven connectivity, and diverse political systems. To address these challenges, there is a pressing need to reimagine multistakeholder digital governance in the Asia Pacific through models that are not only inclusive but also responsive to the region's diversity and lived realities.

Future governance frameworks must prioritise equitable participation, particularly from underrepresented voices and smaller states, and uphold human rights, transparency, and accountability. With growing geopolitical competition influencing digital policy directions, a regionally grounded, collaborative approach is essential – one that treats diversity as a foundation for resilience and ensures no one is left behind in shaping the digital future.

This year's APrIGF took the overarching theme of "*The Future of Multistakeholder Digital Governance in Asia Pacific"*. In exploring this theme, five critical sub-themes were identified; Security & Trust, Resilience, Innovation & Emerging Technologies, Sustainability, and Access & Inclusion.

Live Captioning

- Al vs human captioning study was done earlier in the year and presented to the MSG during the MSG meeting in June. Upon comparison, real time human captioning is preferred, which has greater accuracy in terms of speakers' names, and nuances associated with the Internet governance.

Sign Language Interpretation


With all these efforts to establish a favourable virtual environment, the feedback received was heavily positive, with a few improvements noted for future virtual and hybrid conferences.


Total number of registered participants: 1,188

Geographical diversity of registered participants: 66 economies









Program Highlights

Parliamentary Track

In collaboration with IGF Secretariat and Nepal parliamentarians, APrIGF 2025 welcomed the 2nd edition of the Regional Parliamentary Track on 11 October 2025. The Parliamentary Track was divided into two (2) sessions, across 2.5 hours. The following is a report received from the IGF Secretariat:

Parliamentary Session 1 - Navigating the Net: An introduction to the Internet Ecosystem.

The first session of the regional Parliamentary Track invited technical community representatives to introduce the Internet ecosystem and raise awareness regarding unintended consequences of regulation on the proper functioning of the Internet. The panel distilled concrete do's for drafting digital policy, which include to keep laws tech-neutral and flexible so they do not age out; to "think global, add local" by aligning national rules with the globally coordinated names-and-numbers system (ICANN/RIRs) to avoid splintering the internet; to consult operators and the technical community early through multistakeholder processes to surface operational realities; to balance privacy with accountability so cybersecurity responders can reach the right network contacts lawfully and quickly; and to bake in open standards—notably IPv6, DNSSEC, and RPKI—to future-proof networks, Internet of Things (IoT), and smart-city ambitions. Finally, the panel was encouraged to build state capacity, equip staff regulators with real expertise and use sandboxes. It was further suggested that legislators can immediately leverage the Asia Pacific community by engaging beyond the parliamentary track, by attending main IGF sessions, APNIC open policy meetings, ICANN/IETF fora, and draw on IGF and APrIGF outcome documents when legislative committees need cross-stakeholder policy advice. Finally, they can invite registries/RIRs and network operators to hearings for briefings, borrow peer models via regional parliamentary networks, and request targeted technical training from DotAsia/APNIC. This ecosystem gives lawmakers rapid access to comparative practice, real-world impact tests, and draftable language that travels well across borders.

Practical guidance for lawmakers

- 1. **Think global, add local**: align national laws with globally coordinated systems for names/numbers; avoid rules that conflict with RIR/ICANN policies.
- 2. **Consult early & often**: run **multistakeholder consultations** with operators, CSOs, standards bodies, and RIRs to surface operational realities.
- 3. **Be tech-neutral & flexible**: write **principles-based** provisions that won't be obsolete as technologies evolve; consider sandboxes.
- 4. **Balance privacy & security**: enable lawful, timely access to operational data for cybersecurity while protecting personal data.

- 5. **Promote open standards**: explicitly support **IPv6**, **DNSSEC**, **RPKI**, and other widely recognized best practices.
- 6. **Build state capacity**: staff regulators with strong networking/cyber expertise and support their participation in IGF/APNIC/IETF fora.
- 7. **Leverage IGF assets**: use **IGF messages, APRIGF Synthesis Documents**, and Parliamentary Track outputs as reference material for committees.

How can Members of Parliament benefit from the community

- **Network with peers** (e.g., African Parliamentary Network on Internet Governance) to exchange models and text.
- Tap **technical training** and briefings from .asia/APNIC and others; invite them to hearings and drafting sessions.
- Participate not only in parliamentary tracks but also main IGF program sessions to hear cross-stakeholder perspectives on pending bills.

Parliamentary Session 2 - Governing Digital Platforms in the Asia-Pacific: Strengthening Public Policy through Multistakeholder Insights

The second session of the regional Parliamentary Track on governing digital platforms in the Asia-Pacific urged lawmakers to govern platforms with transparent, rights-based, innovation-friendly rules. Key priorities were discussed to avoid fragmented, reactive laws, to use multistakeholder consultation early (government, digital platforms, civil society, technical experts, youth), to balance safety with freedom of expression and economic growth, and to build state capacity so ministries can coordinate on cross-cutting platform issues. Practical levers include requiring algorithmic accountability and transparency, promoting AI fairness and content-moderation safeguards that do not silence marginalized voices, and calibrating compliance so Small and Medium Enterprises (SMEs) are not crowded out. Legislators were further encouraged to embed inclusion and accessibility by design, treating web/app accessibility as a baseline requirement, while pairing governance with digital literacy to curb mis- and disinformation and support safer participation. Legislators can plug into the community by standing up recurring national forums that bring together all stakeholder groups, with targeted tracks for under-heard groups (women, persons with disabilities, or from rural areas...). This ecosystem gives Members of Parliament comparative practice, operational reality-checks, and draftable language that travels across borders.

Practical guidance for lawmakers

- **Legislate tech-neutral, rights-based rules** for platforms that safeguard freedom of expression while enabling safety, competition, and innovation.
- Institutionalize multistakeholder input early (government, digital platforms, civil society, technical experts, youth) and keep it continuous.

- Require platform accountability: transparency reporting, notice-and-appeal for users, basic algorithmic transparency and impact assessments (with special attention to AI bias).
- Bake in inclusion & accessibility by design: make accessibility standards a baseline for public- and large-platform services; require inclusive UX and language access.
- Calibrate compliance to size/risk so SMEs and startups are not crowded out (graduated duties, safe harbors, model templates).
- Strengthen state capacity & coordination: equip regulators and staff with networking/Al/content-moderation expertise; set up clear lead ministry and inter-ministerial coordination for cross-cutting issues.
- Pair governance with digital literacy programmes to counter mis/disinformation and deepfakes, especially for vulnerable groups.
- **Promote open standards and interoperability** that support a resilient ecosystem and reduce lock-in.

WSIS+20 High Level Session

This session invited and gathered esteemed speakers from various stakeholder groups to discuss the WSIS+20 Review process. Speakers present in this session include:

At this session, speakers shared their respective perspectives on the key focus areas throughout the Review process and what is expected next. The session also focused on what is realistically possible and where the process will lead; region-specific focus and aspects; and a call to action for the Asia Pacific community.

Synthesis Document

The Synthesis Document aims to document items of common interest relevant to Internet governance in the Asia Pacific region and has developed into one of the highlight innovations of the APrIGF and inspired other national and regional initiatives to develop their own processes.

The open input framework document was based on the submitted and accepted workshop proposals for APrIGF 2025, which contain policy questions and basic summary of topics which were discussed at the APrIGF event. Further input was sought at the Townhall sessions during the APrIGF event.

All APrIGF participants were encouraged to attend the Synthesis Document Townhall Sessions during the conference to highlight key issues discussed and give comments verbally or via the commenting platform.
